

### Hospital Parking


October 27

The President and an Executive Member of CRKSG attended a consultation session with Clare Middleton, the Director of Capital Planners ACT, in relation to Pay Parking at TCH. The following update includes an opportunity for members to provide comment.

ACT Health has engaged Engineering consultants, CardnoYoung Pty Ltd, to undertake a number of feasibility studies involving both the Canberra Hospital and Calvary Health Care ACT campuses. The studies will firstly identify options for the introduction of pay parking, and also propose management solutions for free parking for staff and other eligible groups of the hospitals' communities.

A comprehensive parking and traffic study is also being undertaken at both campuses to assess the current demands and capacity of existing parking facilities, and to identify locations and opportunities for the provision of additional parking spaces.

## Nocturnal Haemodialysis

### What is it?

Nocturnal dialysis is slow dialysis that is undertaken during your normal sleeping hours. This leaves waking hours for you to do whatever you like. It is treatment that is undertaken in the home environment and means that a dialysis machine is installed into the bedroom. Nocturnal can be done for anywhere between 3 to 6 nights per week. By dialysing the extra hours of the night even doing 3 times a week can double the amount of dialysis therefore if you dialyse 3 nights per week for 8 hours then you have doubled.

### Benefits include:

- Less side effects of Conventional haemodialysis
- Less dramatic drops in blood pressure from taking too much fluid off during shorter dialysis sessions.
- No fluid restrictions and less diet restrictions.
- Decrease in the use of Blood pressure medications as you don't put so much fluid on.
- No need for a dialysis partner for you to dialyse at home, thus no more regular in centre dialysis.

**Kidney Health Australia**

The International Federation of Kidney Foundations (IFKF) in conjunction with the International Society of Nephrology recently announced 9 March 2006 to be the inaugural World Kidney Day. Each year thereafter World Kidney Day will be celebrated on the second Thursday of March.

Forty two member countries of the IFKF will be participating in this global initiative to highlight the need for early detection and prevention of kidney disease identified globally as growing to pandemic proportions.

In Australia we are facing a blow out in dialysis costs. Recent figures from the George Institute indicate the cost of dialysis for current and future kidney patients over the next ten years is heading towards \$3 billion.

**Dialysis Escape Line Cruise - October 2005**

Following Pat Gordon’s excellent description of the 2004 cruise (see [www.crksg.org.au](http://www.crksg.org.au) Summer 2004 Newsletter) I will concentrate on other factors of the 1<sup>st</sup> 2005 cruise.

After a close examination of the cruise documentation we chose the “Air Connections” feature as it included baggage handling (a baggage cart is recommended at the airport) and free transfer to Darling Harbour and return to the Airport at the conclusion of the cruise.

On arrival at the Terminal we presented ourselves at the Security desk as arranged by Nancy and requested assistance for the embarkation. There was a very long queue of passengers waiting entry to the embarkation hall.

At the due time a P&O provided assistor with a wheelchair guided us through the formalities – Customs, Passport Control and the issue of our cruise card and cabin key tag. If you have a neck band with clip bring it as it will save purchasing one onboard. All entries and exits, bar transactions etc are facilitated via the cruise card and it is vital you always carry it.

Once through the land transactions and using the cruise card we were allowed onboard, after having our photographs taken. We were then taken to our cabin and settled there before the assistor returned for the next person. The luggage duly arrived at our cabin that evening as we set sail.

As I was scheduled first to meet and greet the Dialysis team we presented on Riveria deck to meet Nancy, Wayne (team leader), Steve(doctor), Sam, Ruth and John (renal nurses) and Scott the technician. The administration was quickly completed and my Dialysis sessions established.

When you receive your cruise documentation special attention should be given to the ship’s layout. There are 11 decks and the lifts vary in their maximum level (9,10 & 11).If you are wheelchair bound or use other forms of assistance your only method of access, particularly to the dining rooms, is by lift. Take note that the dining rooms are separated by the galley and if you arrive at the wrong one, access to the other is only by going up or down then along and then back, up or down.

Some destinations (Ouvea, Mystery Island, Isle of Pines) are reached by ship’s tender. The staff are very experienced and helpful to persons requiring assistance both in accessing the tender and disembarking at the destination. At the bigger more populated destinations (Noumea, Vila) minibus transport is usually available.

We had carefully examined the tours available and ruled a line through those we considered difficult or impossible. We had then selected “Noumea Discovery & Anse Vata” only to later discover the “Le Petit Train” with its easier ingress access than the bus, went to the same places.

Dialysis was a bit different in that beds are used and it is wise to take a couple of your cabin pillows to the session. Otherwise you are in good experienced hands and well cared for.

On the whole, the trip was a very pleasant experience and the food was plentiful and enjoyable. It was easily possible to partake of breakfast even if you were scheduled for morning Dialysis. The poker machines paid occasionally, no better or worse than the mainland ones, and the Bingo prizes were worth winning. The entertainment was first class and I even learnt a few new jokes from the resident comedian (assistant Cruise Director – Demo)

Disembarkation was once again a breeze as the company provided two assistors to get off ship, through customs and re-entry and onto the airport buses.

Our thanks go to Nancy and Dialysis Escape Line for organising the cruise and to P&O for the ground support assistance, which was of the highest order both on shore and at sea

**Availability of Calcium Tablets on PBS (Fed)**

Following a submission by Kidney Health Australia (KHA), The Minister for Health and Ageing, Tony Abbott, announced calcium tablets will be retained on the Pharmaceutical Benefits Scheme (PBS) for use by patients who have chronic renal failure. After considering expert advice from the Pharmaceutical Benefits Advisory Committee (PBAC), the government has decided that there is a strong case for retaining PBS listing of calcium tablets for patients with chronic renal failure.

**National Chronic Kidney Disease Strategy**

The National Chronic Kidney Disease (CKD) Strategy is now nearing completion, with the final external consultation phase currently underway. A broad range of stakeholders including clinicians, consumers, service planners and policy makers have been invited to provide feedback, to ensure the Strategy appropriately represents the areas where national attention is required to facilitate comprehensive and holistic best care for patients across the continuum of progressive CKD.

Outside the immediate world of people with CKD, their families/carers and health care teams, issues relating to CKD in Australia are not widely known. Despite the significant burden of disease there has been no national strategic plan addressing CKD issues and planning for the projected growth in incidence and prevalence of CKD.

There are also no systematic national programs addressing ways of bridging the gaps that exist in the delivery of optimal care for people with CKD. In 2004, Kidney Health Australia and Foundation Partner - Servier Laboratories Pty Ltd, embarked on a project to develop a National CKD Strategy. Progress to date has included:

- formation of a multidisciplinary Steering Committee
- national stakeholder workshop in February 2005, opened by the Federal Minister for Health and Ageing, The Hon Tony Abbott
- formation of multidisciplinary Working Groups for each of the six Strategy priority areas: Risk Reduction and Prevention, Detection and Management of Early CKD, Management of Advanced CKD, Dialysis, Organ Donation and Transplantation, and Aboriginal and Torres Strait Islander peoples
- Working Group review and endorsement of their respective priority area
- Steering Committee endorsement of National CKD Strategy Consultation Draft

**Looking for the ultimate Christmas Gift?**

All that's required is a little time to think carefully about organ donation and then sign on to the organ donor register. Call 1800 777 203 or fill in a form from your local Medicare office.

**Admissions to the Canberra Hospital**

Under the Australian Health Care Agreement, all eligible patients admitted to a state or public hospital have the choice to be treated as either public or private patients. It is the duty of all admitting staff to ensure patients are adequately informed of all their admission options to enable them to make their choice.

All patients are free to make their own election choices and at no stage are directed to opt for one alternative over another. However, many patients do not realise: -

- a) *They can use their Private Health Insurance and not be 'out of pocket' in some circumstances, or*
- b) *The benefit to the Hospital as a result of their decision to invoke their Private Health Insurance, ie revenue which is used to benefit both the patients and the hospital.*

Any patient who is advised that there will be 'no out of pocket costs' (NOOPC) for their admission receives a copy of their admission form with a stamp indicating that there will be NOOPC. If they have further doubts or concerns a visit by the Patient Liaison Officer is organised so that she can address their questions.

The patient's health insurance "excess" is a payment made to the Hospital and is therefore taken into consideration when giving the guarantee of not being out of pocket.

I stress that admissions to public hospitals are always determined by clinical need.

**Did you know ...?**

Those big garbage bins can be quite an effort to put out on the street for most of us and just impossible if you are frail or disabled.

Arrangements can be made with Urban Services for those with a disability or who are frail to have their wheelie bins collected from their home, emptied and returned by the Cleanaway drivers.

To access the service you need to meet certain criteria, which involves a form being signed by the applicant's doctor. The form is available by calling Urban Services on 6207 2500.
